

# Nova Scotia Hemophilia Society - Maritime Adventurers Camp Consent and Release Forms

In registering and permitting my child to attend the 14th Annual Maritime Adventurers Camp program to be held August 20th – August 26th , 2017; I the undersigned parent/guardian or other duly authorized party hereby agrees as follows:

- I freely waive all rights to any future claims against Hemophilia Nova Scotia, Hemophilia New Brunswick, Hemophilia Prince Edward Island, its parent organization the Canadian Hemophilia Society, Maritime Adventures Camp or any of these organizations staff/representatives/volunteers due to any accident, injury and/or illness or treatment of the same that may occur during the camp period.
- I grant permission for my child to receive treatment for hemophilia or other medical problems and I consent to the hemophilia nurse to administer such routine medication, as he/she may deem advisable.
- In the event of emergency, if camp personnel are not able to contact me or my designated emergency contact, I give consent to medical staff and camp director to act on my behalf in signing permission for medical care as advised by a medical doctor.
- In the event of an emergency, I give permission to camp personnel to transport my child to the nearest hospital.

In registering and permitting my child to attend the 14th Annual Maritime Adventurers Camp program to be held August 20th – August 26th , 2017; I the undersigned parent/guardian or other duly authorized party hereby agrees as follows:

- Photographs taken by camp personnel of camp activities and children become property of Hemophilia Maritime Region.
- Photographs and/or Video related to Maritime Adventurers Camp may be used in promotional material, public information displays, and other promotional venues and I hereby consent to such use by the Maritime Adventurers Camp and/or Hemophilia Maritime Region.
- This consent will be in force until/unless I revoke it in writing.
